#### **Qualifying Equipment**

- Equipment must be installed in an existing home, no new construction. The home must be electrically cooled and heated. Electrically cooled homes must have a central air conditioner servicing at least 80% of the conditioned space. Electrically heated homes must have an electric furnace or heat pump servicing at least 80% of the conditioned living space.
- Smart Thermostat must be Wi-Fi enabled, programmable climate control device that allows customizable schedule of home temperature. Product must be on the qualified products list at the time of purchase. Occupancy sensor must be enabled.

UAMPS reserves the right to inspect and/or install temporary air conditioning monitoring equipment on any installation of qualifying equipment at any time up to 24 months after installation for quality control of the application or program performance evaluations. Incentive qualifications and amounts are subject to change and termination at any time. Participating energy partner's customers should visit the program website at: smartenergy.uamps.com or contact your local dealer to determine whether program changes have occurred.

Customer agrees to transfer to its participating energy partner all "environmental attributes" attributable to the qualifying equipment or its operation.
