- **6.** Upon completion of the lighting project, applicant will notify UAMPS SmartEnergy at **888-365-1558** to schedule a post-installation inspection.
- 7. Once post-installation inspection is complete, UAMPS SmartEnergy will issue the applicant's incentive check.

Terms and Conditions

Qualifying Customers: Commercial electric customers who purchase their electricity from a UAMPS' participating Smart Energy Partner are eligible to participate in the Commercial Lighting Program.

Application details: UAMPS is administering this incentive program for its participating Smart Energy Partners. Please reference the program website: **www.smartenergy.uamps.com** or by calling **1-888-365-1558** to determine eligibility. All equipment must be new. Applications must include all requested information. Incomplete applications will be returned causing delay or denial of the incentive.

Post Installation Documentation: The incentive application will not be processed until the preauthorization inspection has been completed by the UAMPS Smart Energy Partner. UAMPS reserves the right to inspect any installation of qualifying equipment at any time up to 24 months after installation for quality control of the application or program performance evaluations. Incentive qualifications and amounts are subject to change and termination at any time. Applicant's agrees to provide any reasonable documentation to allow UAMPS Smart Energy Partners to determine actual costs incurred. Notes to "Exhibit A": Retrofit Lighting Efficiency Requiremets and Incentive Levels

- 1. In order for the incentives to be approved, the new lighting system must use less energy than the existing lighting system replaced or the baseline lighting system as determined by UAMPS Smart Energy Partners.
- 2. Two-foot U-tube lamps may be substituted for 4' linear fluorescent lamps.
- 3. Incentives for T8 Fluorescent Premium delamps may not be combined with other linear fluorescent lamp or fixture incentives. Complete fixture removals are not eligible. An existing 8' lamp is counted as two (2) 4' lamps and may receive premium delamp incentives when replaced with qualifying equipment.
- **4.** Incentives for T8 Fluorescent relamps may not be combined with other linear fluorescent lamp fixture incentives and will only be paid once per facility.
