Applications must include all information requested. Incomplete applications will be returned causing delay or denial of the incentive.

Residential electric customers who purchase their electricity from a participating UAMPS energy partner qualify for this program.

Application Details

UAMPS reserves the right to conduct random inspections to verify information provided on the application. If your application is selected for review, it will not be processed until the review is satisfactorily completed. Incentive qualifications and amounts are subject to change and termination at any time.

The customer hereby transfers to its electric utility all "Environmental Attributes" attributable to the Qualifying Equipment or its operation. Environmental Attributes include any and all credits, benefits, emissions reductions, offsets and allowances, howsoever entitled, resulting from the avoidance of the emission of any substance to the air; soil or water at or by the electric utilities generating facilities through reduced generation of energy or other savings or offsets on account of the Qualifying Equipment. The customer will not claim ownership of any Environmental Attributes.

All incentives issued are in the form of checks not utility bill credits. UAMPS and its energy partners are not responsible if your dealer provides inaccurate information about the amount and/or conditions of the actual incentive and will not pay incentives for equipment that is mislabeled or misrepresented by dealers regarding incentive qualifications. Incentives are limited to one per qualifying household per equipment type, except in the case of lighting. Please check **smartenergy.uamps.com** for individual limits.
