Qualifying Customers

Residential electric customers who purchase their electricity from a UAMPS participating energy partner are eligible to participate in the Cool Cash Incentive program.

Qualifying Equipment

Qualifying equipment for the 15+, 17+, 20+ SEER/12.5+ EER central air conditioning equipment incentive must meet the requirements outlined below. Window air conditioning units, packaged terminal units and heat pumps are not eligible for incentives under the Cool Cash Incentive program.

To qualify for the proper installation incentive, documentation of a properly installed unit must be provided by the participating dealer, and the central air conditioning unit must be installed according to the requirements provided in the Cool Cash Incentive Program Manual for participating dealers. Requirements include equipment installation and completion of UAMPS' Proper Installation Form by an individual certified by North American Technician Excellence (NATE) in air conditioning installation.

Additional incentives are available for equipment properly sized to match the calculated cooling load of the residence where it is installed. Installed equipment is considered properly sized when it is within one-half ton (6,000 Btu/hr) of the calculated cooling load as determined using the Air Conditioning Contractors of America (ACCA) Manual J sizing procedure. The size of the installed unit will be the standard capacity rating as reported in the current Air Conditioning and Refrigeration Institute directory of unitary equipment. Your participating energy partner specifically requires the use of the following summer design conditions when calculating the cooling load:

All equipment must be new and have been purchased and installed prior to submitting an incentive application. Applications must include all information requested. Incomplete applications will be returned causing delay or denial of the incentive.

UAMPS reserves the right to conduct random inspections to verify information provided on the application. If UAMPS inspects the equipment, the incentive application will not be processed until the inspection has been satisfactorily completed. UAMPS reserves the right to inspect and/or install temporary air conditioning monitoring equipment on any installation of qualifying equipment at any time up to 24 months after installation for quality control of the application or program performance evaluations. Incentive qualifications and amounts are subject to change and termination at any time. Participating energy partner's customers should visit the program website at: **smartenergy.uamps.com or contact your local dealer to determine whether program changes have occurred**.

Customer agrees to transfer to its participating energy partner all "environmental attributes" attributable to the qualifying equipment or its operation. Environmental attributes include any and all credits, benefits, emissions reductions, offsets and allowances, howsoever entitled, resulting from the avoidance of the emission of any substance to the air, soil or water at or by electric utility's generating facilities, through reduced generation of energy or other savings or offsets on account of the qualifying equipment or otherwise. Customer will not claim ownership of any environmental attributes.

All incentives are issued in the form of checks not utility bill credits. UAMPS and your energy partner are not responsible if your dealer provides inaccurate information about the amount and/or conditions of the actual incentive and your participating energy partner will not pay incentives for equipment that is mislabeled or misrepresented by dealers regarding incentive qualifications. Incentives paid to customers are limited to two (2) per qualifying household per qualifying measure. Customers may apply for up to two (2) evaporative equipment incentives for the same measure, and up to two (2) central air conditioning equipment incentives for the same measure where such qualifying equipment is purchased and installed on the same existing residence and meets all other program requirements.
